The Victorian Transport Association has welcomed the approval of an Inquiry into the Road Transport Industry following a vote in the Australian Senate yesterday. Heavy Duty truck sales show August decline

August saw sales in the truck and heavy van market drop by 14.3 per cent for vehicles with a Gross Vehicle Mass (GVM) of 3,500kg and over, compared with the same period last year. Sales in all truck and heavy van categories declined since August 2018, with the heavy vehicle market showing clear signs of slowing in 2019, with month-on-month lower sales recorded. The Heavy-Duty market struggled with the segment registering only 986 units, a drop of 21.6 per cent compare to this time last year. However, the year-to-date trend is more positive, with Heavy sales tracking down 7.9 per cent over this period last year.

NHVR to trial new PBS Design Approval Process

The <u>National Heavy Vehicle Regulator</u> (NHVR) is trialling a new process for <u>Performance-Based Standards</u> (PBS) Design Approval applications submitted in the lead up to the next PBS Review Panel meeting on 29 and 30 October. The new process is in response to industry feedback and will include a range of steps relating to processing applications. Federal and State Government pledge \$367.5 million to upgrade Monash Freeway

Under a joint commitment between Federal and State Government, a pledge of \$367.5 million has been made for further upgrades to the Monash Freeway. As part of the upgrade, an extra 36 kilometres of new lanes will be added to help ease congestion in Melbourne's east. The second stage of the project will expand the Monash from eight to ten lanes between Springvale Road and EastLink, and from four to six lanes between Clyde Road and Cardinia Road – which is estimated to reduce the morning peak hour trip between Pakenham and Malvern by up to nine minutes. Construction of the new lanes will commence in early 2020 and is expected to be completed in late 2022. Further information about the upgrades can be found here.

NTC unveils Effective Enforcement Issues Paper for comment

The <u>National Transport Commission</u> (NTC) has unveiled its <u>Effective Enforcement</u> issues paper as part of the ongoing <u>Heavy Vehicle National Law</u> (HVNL) review. The seventh of eight papers emphasise data and technology usage and identifies that are several challenges relating to data ownership, security, quality and sharing within the industry. With the goal of the review to achieve a modern, outcome-focused law that improves safety and supports increased productivity and innovation such as new technologies and methods of operation the HNVL is seeking feedback.
