# **VTA contributes to NTC review of National Heavy Vehicle Law**

A major focus for the VTA in 2019 has been responding to the NTC National Heavy Vehicle Law (NHVL) Review, which has involved consultation with the VTA Committees and feedback from individual members. The following submissions have been completed and lodged with the NTC, and are available via the <a href="member portal">member portal</a> of the VTA website:

- Submission No 1 A Risk-Based Approach to Regulating Heavy Vehicles May 2019
- Submission No 2 Effective Fatigue Management August 2019
- Submission No 3 Easy Access to Suitable Routes August 2019
- Submission No 4 Safe People and Practices September 2019
- Submission No 5 Vehicle Standards and Safety September 2019

We are now preparing the submissions for the last two Issue Papers, Submission No 6 <u>Effective Enforcement and Assurance</u> and Submission No 7 <u>Assurance Models</u>. ## Time running out to apply for labour hire licences

Victorian labour hire businesses have just over one month to register for the Victorian Government's Labour Hire Licencing Scheme, or else face significant penalties. From 30 October, only labour hire providers who are licensed or are awaiting an application decision will be allowed to operate in Victoria. This Scheme – which is overseen by the Labour Hire Authority – was established following the independent Victorian Inquiry into Labour Hire and Insecure Work, which uncovered widespread abuse, underpayment and exploitation of workers in the labour hire industry. The VTA urgers all members to familiarise themselves with the details surrounding who is a 'labour hire provider' as it can include situations where a transport company manages a contract for a client with a fleet of independent contractors and such fleet is integral to the business of the client.
